APPLICATION FOR 2018 BANNER MOUNTAIN ARTISANS SHOW

November 17 & 18, 2018

PART 1

Features of this show include a well-lighted venue, enough interior space for 31 artisans and a large parking lot. For each booth, the Elks Lodge will provide chairs and 8' tables. Tables are required to be covered to the floor with no table legs or boxes of supplies being exposed. No E-Z Ups are allowed, and partitions between the booths cannot exceed 7' in height. Artisans must be present for both days of the show and remain until closing time. Booth sizes are approximately 80 – 100 square feet. There are no double booths available.

Fees for BMA are comprised of an annual operational fee of **\$75.00** plus a booth rental fee at \$0.82 per square foot. EX: 90 sq. ft. x \$.82. = **\$73.80**. The operational fee of **\$75.00** plus the booth fee of **\$73.80** equals a total of **\$148.80**. These fees cover rent for the Elks Lodge, advertising, literature and our website.

BMA will determine booth location based on available space and a balanced distribution of artist's media.

Eligible media includes painting, photography, prints, sculpture, wood, fiber, stone, clay, glass, metal, leather, mixed media, jewelry, sewing arts, and more. No foods such as preserves, chocolate, breads, etc. are eligible.

Jurying requirements:

1. Digital images should be high quality jpeg or tiff formats.
2. Printed photos must be no smaller than 4x6 on high quality photo paper.
3. If you have a website showing your work, please provide the address.

You may be asked to meet with the Jurying Committee to show your art.

Please provide a self-addressed, stamped envelope to return your work.

**Only the type of art you provide for jurying will be allowed at the show.  
You may sell *only* your own work at our show.**

If you have any questions or concerns regarding the requirements for jurying, please call Judy Rath (530) 263-4480. We may ask to view your art in person.

Accept/non-accept letters will be mailed within 2 weeks of jurying.

All fees are due and payable two weeks after acceptance.

100% of fees are refundable until June 30<sup>th</sup>, 2018

After June 30<sup>th</sup>, 2018 **NO** fees are refundable.

We have one business meeting per year, usually late September or early October. Each artisan's attendance at these meetings is very important for finalizing all details, meeting new artisans, sharing last minute information and distributing any available advertising.
